"I was working directly for a three-star, and he suggested EO," she said, preferring the challenge as an alternative to recruiting duty.

Following a military career that culminated as an Equal Opportunity counselor, Vickers decided to up her "E" count as a civilian.

"After retiring from the military, I became an HR Generalist for a little while, but really wanted to get back into my field of helping people resolve issues," Vickers said.

With her master's degree in HR, the transition from HR was a logical step.

EEO requires an extensive knowledge of the law and rules regarding the complaint process.

One gets the sense that helping those with less power is part of the equation, and her lifetime of familiarity with the Army is a source of knowledge.

Outside of work, her love of travel, comedy and comedy clubs helps her decompress from the serious business of EEO.

"My father was military as well, as a brat we travelled all over the place," she said with a smile. "As a brat, my favorite was Livorno, Italy," she said. "As a soldier, I enjoyed Izmir (Turkey) the best."

Her travelling finally prompted her decision to apply here, back to the state she was born in.

"I have family in Florida, and always wanted to work for SOUTHCOM, I plan to stay."
